

Welcome to Atlanta, or, for many of us who have been to AAIDD conferences in the past, back to Atlanta! It is particularly gratifying to come back to Atlanta given the recent courageous veto by Governor Nathan Deal of a bill that would have allowed segments of the community to discriminate against people who also deal with the impact of stereotypes and labels. We all know stories of businesses, neighborhoods, schools, congregations and other organizations who have refused in the past to welcome people with intellectual and developmental disabilities. Both the spirit and practices of hospitality, equal access for all, and welcome for all, are key to our mission as an organization.

What's more, we are meeting in a city that was a major center in the civil rights movement in the last century, a movement that is ongoing. We meet within walking distance, or a short ride east on the Auburn St. trolley, of the Martin Luther King Memorial. Take the trolley west, and you can visit the relatively new national Civil and Human Rights museum in Centennial Park. There, you can both see and feel how the civil rights movement helped inspire the disability rights movement. On Monday evening, that welcome continues as a number of the Georgia leaders in disability rights and services who have had impact both here and around the country join us for the opening reception, along the AAIDD Board and staff, and the Local Arrangements Committee, led so ably by our two Co-Chairs, Dr. Carol Britton Laws and Mr. Curt Harrison.

Equal rights to access and participation does not mean there is always welcome and hospitality. Rights can create a space in community settings, but relationships move us from inclusion to friendships, memberships, and belonging. The AAIDD has played important roles in rights, advocacy and policy with people with intellectual disabilities and their families. Members have developed and published cutting-edge research to improve services and supports, and many more have combined research and policy into more effective practice. Those three "pillars" of AAIDD will all be part of this conference, thanks to all of you who submitted proposals for presentations, guidance from the Conference Planning Committee, and reviewers of proposals with the difficult job of making choices for the final program.

AAIDD is and has been primarily a professional association. The core question we will explore together is what it means to be a professional in an era of rapidly changing understanding of disability as well as growing awareness of the crucial role of real relationships in every day community life and settings for lives full of quality and purpose. But I also hope the questions will be an explicit part of the cutting edge pre- and postconference workshops; 30 concurrent sessions; multiple posters; and the conversations in hallways, at breaks and meals, and in networking meetings that are so crucial to the spirit and effectiveness of any conference. Welcome to an annual meeting of the professional Association that has been a home for me for forty years. (Though not at first! I thought I was the only one who did not know anybody.) Please help us make it feel like home to everyone attending so that we can all take home both renewed commitment and new ideas for the professional journeys we have chosen and that have, in many cases, chosen us.

Welcome to Atlanta!


There is no time like the present to visit the South's largest city. Around every corner is a new attraction, restaurant, or shopping opportunity.

Prior to the arrival of European settlers, the area where Peachtree Creek flows into the Chattahoochee River was a Creek village on the borderlands of the Cherokee and Creek nations known as "Standing Peachtree." Much of Atlanta's main street, Peachtree Street, follows the Creek Peachtree Trail.

The city of Atlanta was formally established at the intersection of two railroad lines, and the city grew as a railway hub. While most of Atlanta was burned during the Civil War, during the first decades of the 20th century, the city experienced a period of unprecedented growth. In three decades' time, Atlanta's population tripled and the beginnings of the city's skyline began to emerge.

With more than \$2.5 billion in development opening through 2017, Atlanta's skyline is changing as frequently as the seasons. In 2014, Atlanta saw the downtown opening of two major new attractions, while new chef-driven restaurants and high-end shopping continue to spring up throughout town, giving the city a fresh new look and taste begging to be explored.

Whether it's award-winning theatre, blockbuster concerts, or festivals, Atlanta has something for everyone. With so many things to see and do, it's easy to see why Atlanta is one of the most popular travel destinations in the Southeast.





In this session we will explore how pathfinders and their partners co-create self-directed journeys to social inclusion. Providing pathfinders with good partners usually calls for deep changes in the way assistance is organized and offered. We will draw on our experience to identify what assists people's diverse journeys to social inclusion and what it takes to make necessary organizational changes.

Our intention is to offer participants an opportunity to think about these design questions:

- How might the practice of person-centered planning amplify the voices of people with IDD who want contributing social roles in community life?
- How might service providers act as partners in the creation of social inventions necessary to realize community inclusion?
- How might we encourage and develop direct support workers as respected and effective allies for pathfinders?
- How might pathfinders and their partners claim the space for innovation?

The Disability Rights movement grew out of the Civil Rights movement and the advocacy movements led by people with disabilities and parents, culminating in the ADA, which recently celebrated its 25th anniversary. This session will review this history and explore and discuss current issues, directions for the future, and the role of rights and advocacy in building inclusive communities. End of Life Decisions for People with Intellectual Disability

Decision-making is a fundamental right, and no less so than for people with intellectual and developmental disabilities. The overwhelming majority of people with intellectual disability have the capacity to make their own decisions, but, like most people, seek the counsel of significant others, family members and friends when making difficult and complex decisions about health care choices. This session will explore issues related to decisions that impact the end of life. The session will review tools that have been developed to assist the person and their support team obtain specific information about their health care and consider the impact that a life-threatening illness or set of chronic diseases can have on the quality of their life. Participants will be presented with a set of guidelines developed to enable a support team examine the ethical issues involved in end of life decision-making and will apply the guidelines with several scenarios where a decision needs to be made to continue traditional health care or transition to palliative care. The session will also explore the complexities of identifying the best interests of the person who has never had the ability to describe their wishes, including surrogate decision-making and disparities in care planning and service delivery.

Supported Decision Making: Research, Policy, Practice

This session will explore research, policy, and practice related to supported decision making. Definitional frameworks for supported decision making will be introduced, as well as practice based examples of its applications. The reports of individuals who have taken advantage of supported decision making will also be included. Emerging policy directions related to the United Nations Convention on the Rights of Persons with Disabilities and legal decisions in the United States will be highlighted. Future directions for the application of supported decision making to enhance self-determination and quality of life will be described. A focus will be on emerging research and practice directions.

Fostering Leadership in Research: Research Colloquium (offsite)

The purpose of this colloquium is to provide an opportunity for AAIDD students and early career professionals to present research findings and obtain feedback on how to translate their research into meaningful research, policy, and practice implications (developing a discussion section). Participants will present a review of literature, research questions, methods, and results in a Pecha-Kucha style (20 slides, 20 second per slide). Members of the Georgia State University faculty and the Research Division will provide feedback to the participants on how the research fits into research, policy, and practice related to individuals with IDD. Discussion will also involve how to share findings in multiple locations (i.e., peer-reviewed journals, practitioner-based journals, blogs, etc.).

COMPLIMENTARY PRECONFERENCE SESSION



Got Plans? Supporting Aging Caregivers and Adults with IDD to Plan for the Future

Planning for the future is important for all families that include an adult with IDD, and professionals play a critical role in supporting families through the planning process. Thinking about the future can be challenging and emotional; however, experience shows that adults with IDD make a better transition from the family home when a future plan is in place. Some families may feel that future planning is not an option for them because they don't have any money to leave to an adult son or daughter with IDD or can't afford a lawyer or estate planner. HENRI J. NOUWEN LEADERSHIP AWARD

2016 Henri J. Nouwen Leadership Award *to* **Benjamin T. Conner, PhD, MDiv**

Dr. Conner's expansive work in the field of theology and disability is a tribute to the work of Henri Nouwen. Dr. Conner's intellectual endeavors, vocational leadership, research, and writing are an integrated whole-committed to loving, serving, and learning-with people with intellectual and developmental disabilities. Dr. Conner has devoted his life to deepening the



educational process and the church's understanding of and ministry with people with disabilities. His doctorate is from Princeton Theological Seminary; he is a Reformed theologian and renaissance man who seeks wisdom from myriad of disciplines as he pursues a holistic and integrative theology for his ministry with people with disabilities.

Dr. Conner came to Western Theological Seminary (WTS) in Holland, Michigan in 2013. His earlier work, outlined in his book *Amplifying Our Witness: Giving Voice to Adolescents with Intellectual Disabilities*, and embodied in his leadership with Young Life Capernum Ministries, brought him to WTS to lead the Seminary into a deeper engagement and wisdom with the largest minority group in the world. Dr. Conner will launch the first-ever seminary graduate certificate in disability and ministry in 2016.

Dr. Connor's inspiration and guidance is particularly felt at WTS' Ralph and Cheryl Schregardus Friendship House. Established in 2007, the apartment complex is home to six people with cognitive disabilities who live interdependently and work in the community, and to 18 seminarians, who live alongside the young adults with disabilities. Under the leadership of Dr. Conner and his wife Melissa Connor, the Director of Friendship House, the seminary community integrates housing with education in the spirit of Henri Nouwen. Other seminaries are beginning to develop their own Friendship Houses.

Dr. Conner's work has, is, and will transform the manner in which faith communities' support and engage people with intellectual and developmental disabilities to flourish. He lives calmly in Nouwen's vision that leadership in ministry "means the ongoing attempt to put one's own search for God, with all the moments of pain and joy, despair and hope, at the disposal of those who want to join this search but do not know how."
