### **Annual Report**

For the year that just ended (July 1-June 30), indicate objectives met, activities completed, and funds used.

### Objectives:

Recruitment of a 3<sup>rd</sup> Executive Committee member was accomplished. Sylvia Melancon, from Louisiana, was present at the Business meeting and volunteered to join the Executive Committee. Another Convention attendee also expressed interest. Unfortunately, neither of the other Executive Committee members (Alya Reeve & Angela Hope-Weusi) were able to attend the St. Louis Convention, but both have expressed interest in continuing to work on the Interest Group activities.

The Chair attended the meeting of the Assembly of Professional Interests, during which status reports were provided by representatives of each of the Interest Network groups. In addition, there was considerable discussion of various social media options for communicating about the group's activities and available information about the area.

Although it is not known how many of the presenters are members of the Multicultural Interest Network, there were 6 posters and 7 session presentations in which multicultural issues or diverse populations were a focus. This count excludes presentations/posters regarding countries other than the U.S.

A business meeting was subsequently held at the St. Louis convention. The discussion focused on learning activities available about multicultural issues. The need for an increased social media presence for this group was discussed at length. Ms. Melancon indicated that she would be able to contribute in this area.

No funds were used. Only \$300 are currently available. The only known previous use of funds was financial support for a student presenting on multicultural concerns at the 2016 Convention.
